#### TREASURERS REPORT TO THE COMMITTEE MEETING 14 APRIL 2019

- 1. DRAFT Income and Expenditure and Balance Sheet attached
- **2.** Club Levies: I have not had time to calculate Club event Levies so I have used 2018 figures to fill the space. Accurate bills to clubs will follow shortly!
- 3. Levy for clubs outside Wales Duncan Harris from DEE pointed out that they had been paying too much levy in accordance with an agreement made in 2012. Considerable research was done into this with the help of Duncan Harris, Stephen Round and John Butler and it appears he is correct but they are not pursuing a refund!
- **4. CROESO:** I am still trying to get up to date with CROESO and I have a meeting with the bank on Friday (12<sup>th</sup>). There is still an amount of money in the Croeso bank account that will be available to clubs for expenses in the run up to CROESO 2020.
- 5. Admin: includes the Auditors fee but the current auditor is unable to continue and I would like the meetings agreement to approach a local Chartered Accountant. Full accounts sent to Sport Wales to support our grant applications have to be signed off by someone independent. I am hoping that the audit fee will remain the same as I have given them work in the past!
- 6. Volunteer training Weekend 21 June 2019: We have paid for the Plas Dolau accommodation but it does not form part of these accounts. As the Volunteer Training weekend will not take place until the next financial year it will appear in next year's accounts (2019/20).
- 7. Grants for International & Training: As far as I can see there were no applications for funding for training. Financial help was given to those selected for WUOC, WOC World Cup 3.
- **8. VHI** had a grant comparable to 2018 as did **JHI** who received the same amount. There was no application to help with funding for the **SHI**!
