4. REPORTS OF OFFICERS FOR 2012 - All published in the WOA Annual Report for 2012

a. Chair's Report – none as no Chair in 2011-2012

b. Treasurer's Report

AP explained the 2 formats: Appendix 1 is the Income and Expenditure Account in the format required for Sport Council Wales (SCW).

Appendix 2 is the Revenue Account

The Auditor has approved accounts for 2012.

DP asked if SCW note the jump in figures every 4 years and comment on this? AP replied that she did mention this in the report when applying for the grant.

Proposed: Judith, seconded: Roger Stein. Accepted.

c. Membership Secretary's Report

RS pointed out current figures have been provided, rather than the figures for the end of 2012. PR accepted that and will provide figures for end of 2012.

360 was the total for 2012 (October). Slightly down on 2011.

2012 was last year for old structure of membership – family etc.

2010 : 393 2011: 382 2012: 360

Trend is downwards. JP commented that other clubs are noticing the same trend. AP asked if PR contact individual people to ask why they are not renewing. He does not contact them directly, but does send lists of those who have not renewed to club secretaries. Reasons for not renewing are normally: moved out of area, or not orienteering any more.

RS: SBOC – some improvement in club's membership figures

Eryri: membership is now down to 25.

DP: large clubs can put on events nearly every week so there is continuity.

JE commented that the Street event series by Claire Dallimore for ERYRI was very well attended, lots of students, but that did not flow through to ordinary events.

A discussion ensued on why o numbers are reducing – no easy solution.

- *i.* Proposed Constitution amendment to reflect changes in membership structure. Recommendations as follows:
 - Delete Families (RG) and Groups (RS)
 Only pay more than last year when more than 4 children. PR could record families (groups at same address). Agreed to delete family and groups
 - 2. The Group category should be dropped agreed
- d. Development Officer's Report no discussion
 - 1. 18.1.C to be amended
- e. **Fixtures Secretary's Report** participation figures got by AP when she gets the levy figures for events. She does not get figures for introductory events nor for how many run on each map. Members/non-members/parents or shadowers on BOF form, but no levy charged on the parents or shadowers etc. could ask BOF for participation figures for WOA. DP is going to see if he can get access to BOF's figures.

This appears to be the most promising system to replace Photogrametric Plotting as a major mapping tool. There is a lack of recent aerial photographs that are needed for PG plots.

Is any income from JK 2014 included in budget? Not yet but AP will contact Helen Errington to find out prospect and will amend as appropriate.

RS was concerned that we should not let SCW understand that we think we will not get their grant, AP will amend to take SCW in to account.

She will increase dev grant up to £5,500.

Approved subject to the amendments proposed. Amended budget to be proposed at meeting after today.
