5 c. **Croeso 2016:**

There is some interest from SBOC, who have a subcommittee in place and have some potential areas in mind. RS pointed out that even though it is possible that the event would potentially be in the SBOC area they did not expect to have to fill all the key posts for the event from within the club. The event is currently pencilled into the BOF calendar for the week commencing the 31st July. It was pointed out that the event was not always held that early and the following week was more typical. DP agreed to look at which other major multi day events have been scheduled around then and to propose an appropriate week.

5 d. **JK 2014**: PR: Dave Peel is currently remapping Pwll Du for the relays and updating Merthyr Common and Mynydd Llangynidr. Helen Errington (BOF) and Tim Pribul (Day2/3 controller) will be down early July to look at assembly areas etc. MS raised the question of the partnership agreement and whether it is with WOA or the individual Welsh clubs. PR to clarify this with either Helen Errington or Nigel Ferrand.

8 Any other business.

a. The request from Mike Hamilton from British Orienteering for members from the WOA to be part of British Orienteering steering groups was discussed. The required is for one person from the WOA to a members of the following steering groups (Development, Talent & Performance and Coaching) as well as a person within WOA to be the point of contact for strategic planning purposes. MS agreed to be the person on the Development group (at least on an initial basis. PR agreed to be the point of contact. It was proposed that HB be asked if she would take on the role on the Coaching steering group, PR to ask her. No one came forward or was suggested for the Talent & Performance group. PR also to inform Mike Hamilton of the proposals.

- b. RG requested that the travelling expenses for Rob Postlethwaite who is travelling to Wales to put on a mapping course be funded by the WOA. This was approved.
- c. The issue with regard to the WOA fees being included in the club fees for 2014 was discussed. There was consensus that the best way going forward was that the WOA element should be

shown separately. This should ensure that WOA actually gets the revenue earlier than it currently does. Club membership secretaries will need to be informed so that when BOF request the fees for 2014 the clubs understand how this will work. AM to contact club membership secretaries / treasurers to inform them.

d. RS mentioned that at short notice Kris Jones of SBOC had been selected to represent the senior GB squad in Finland. Travelling expenses for the trip would be £450. It was agreed that the WOA would fund one third of this. This is in addition to the similar funding ratio for the other Welsh juniors selected for various tours this summer.
